I am to state that the General Body of this Council at its meeting held on 22/11/2016 considered the Council Assessor's Report (24.08.2016) on the physical and other teaching facilities available at ESI-PGIMS, ESI-Hospital, Andheri(E), Mumbai for the award of MD(Biochemistry) qualification for 2 seats under Maharashtra University of Health Sciences, Nashik. The Council approved the following recommendations of the Postgraduate Medical Education Committee, which I am directed to convey herewith for your information and necessary action:-

"The Postgraduate Medical Education Committee considered the Council Assessor's Report (24.08.2016) and decided to recommend to the Central Government that MD(Biochemistry) qualification for 2 seats granted by Maharashtra University of Health Sciences, Nashik in respect of students being trained at ESI-PGIMS, ESI-Hospital, Andheri(E), Mumbai be recognized and included in the 1st Schedule to the I.M.C.
